If the resin frame or backrest of the Nautical Pro, Nautical, Marina, and Catalina chaise fails structurally or discolors, under normal usage within three years from the date of purchase, Grosfillex will repair or replace the frame or the backrest of the chaise without charge (parts and labor included). Grosfillex warrants the fabric of the sling chaise one year from the date of purchase against discoloration or fading due to the sun's ultra-violet rays. Grosfillex will replace the fabric at no charge to the customer (labor not included). This warranty does not apply to color changes due to staining. For more information on this matter, refer to the cleaning instructions provided by Grosfillex.

GROSFILLEX SHALL NOT BE RESPONSIBLE FOR ANY LOSS, DAMAGE, EXPENSE OR INCIDENTAL OR CONSEQUENTIAL DAMAGES OF ANY KIND ARISING OUT OF ANY DEFECT IN GROSFILLEX PRODUCTS. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you.

This warranty does not extend to goods which have been damaged, altered, abused, misused or repaired after leaving Grosfillex facilities, or which have been repaired or otherwise altered in any manner outside of such facilities, unless previously authorized in writing by Grosfillex.
